However, in order to offer installers additional selling benefits and homeowners a more appealing security enhancement, VEKA Group is pleased to introduce an innovative yet simple PAS 24 ready solution to the Imagine Patio Door.

Partnering with ERA, with their long-standing heritage of high quality security hardware and innovation, we have developed a high security interlock claw profile design which provides a host of benefits for the entire supply chain, from fabricator to homeowner.



In order to make the PAS 24 ready Imagine Patio Door options as simple as possible, VEKA will be stocking locks and hardware, as detailed on page 10.

With its clean aesthetics, high quality and raft of selling benefits, the Patio Door fits comfortably with the rest of Imagine range. Available in our full Variations range of colours and the option of chamfered or sculptured beads.

Enhanced security testing has been carried out to PAS 24:2016, completed using the largest possible sash size of 1500mm wide 2300mm high. This allows VEKA to cascade test data to fabricators and installers of the Imagine Patio Door in a structured way that enables compliance with Document Q of The Building Regulations.

At a stroke the new PAS 24 ready Imagine Patio Door has greatly simplified achieving this security standard, sweeping aside many of the fabrication, installation and aesthetic challenges thrown up by more traditional solutions.

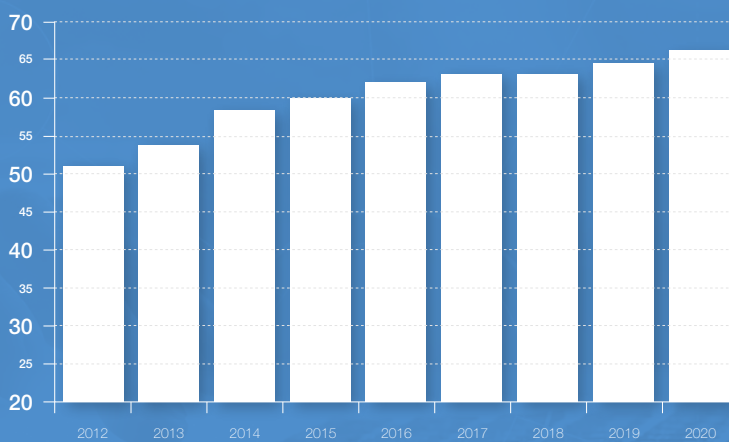


The market for traditional sliding patio doors is forecast to maintain modest growth and remains heavily dominated by PVC-U at 84% share of market.
